- B. Submit a copy of the document evidencing the organization of the LLC (e.g., Certificate of Formation, Articles of Organization, and Operating Agreement). The submitted documents must include the name of each of the members and clearly state how management of the LLC will be vested (i.e., by *members, managers, officers*). Information as to citizenship of each entity should also be provided either in a cover letter or a separate statement.
- C. A \$5.00 registration fee made payable to the FAA.
