

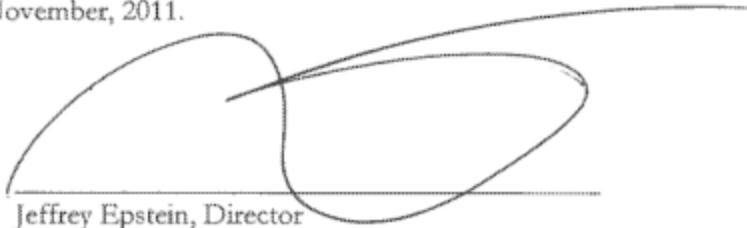
Corporation to transact business therein; and it is further

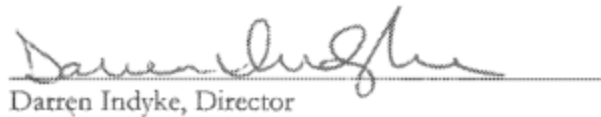
RESOLVED, that the Corporation proceed to carry on the business for which it was incorporated.
