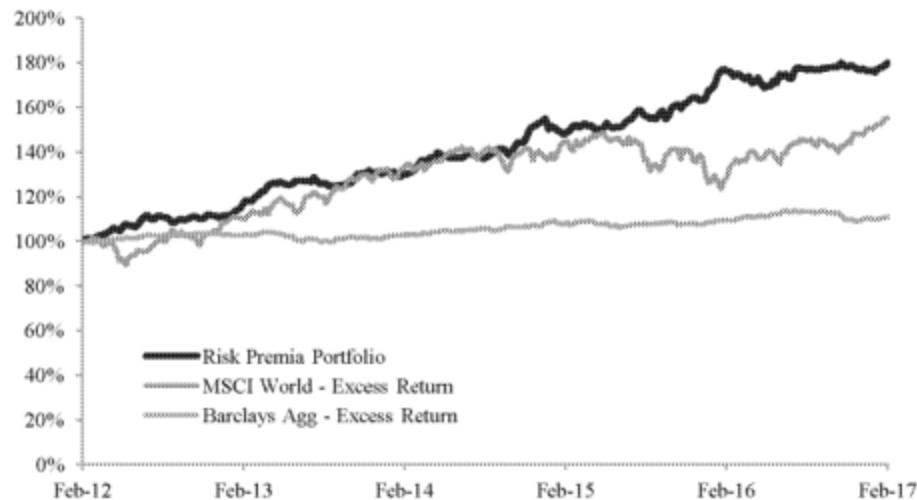




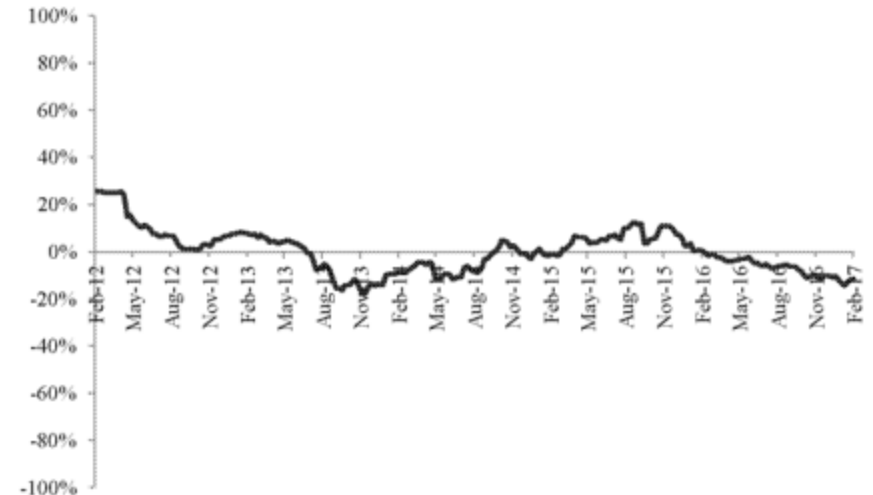

Historical Performance vs MSCI World and Barclays Agg



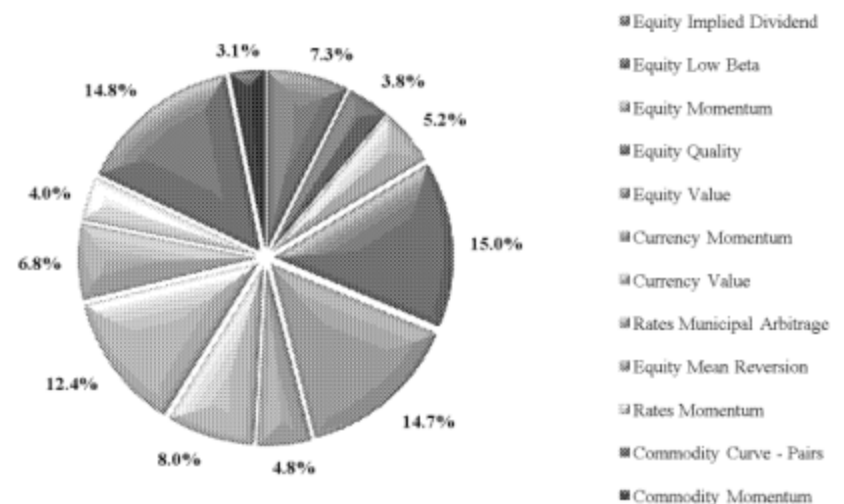
Rolling 2 year Correlation MSCI World - Excess Return
