If a tolerance is provided, then the tolerance percentage will be calculated and lower the maximum total amount. For example Tolerance of 10% with Maximum Total CTR Amount of \$30,000 would lower the maximum evaluation to \$27,000. Individual transactions must be at least \$9,000. Designed to be run Post-EOD on a monthly or quarterly schedule. The recurrence period is monthly.
