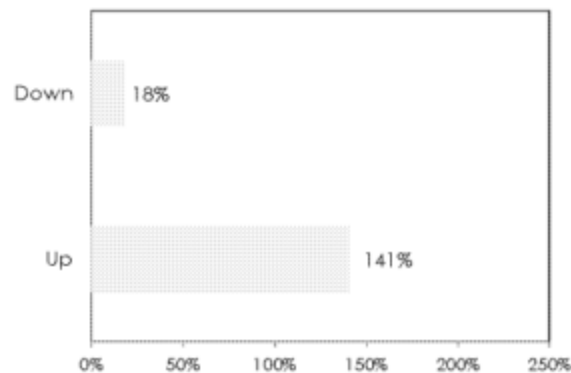


Asymmetric Upside/Downside Participation

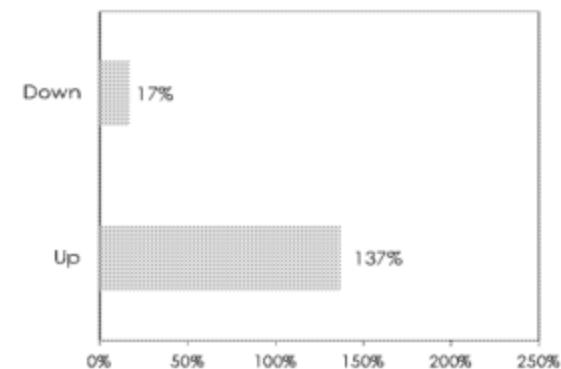
January-1998 to December-2016

Combination of strong double Alpha and net-long bias has resulted in significant upside participation and limited downside participation over time periods greater than one year.
