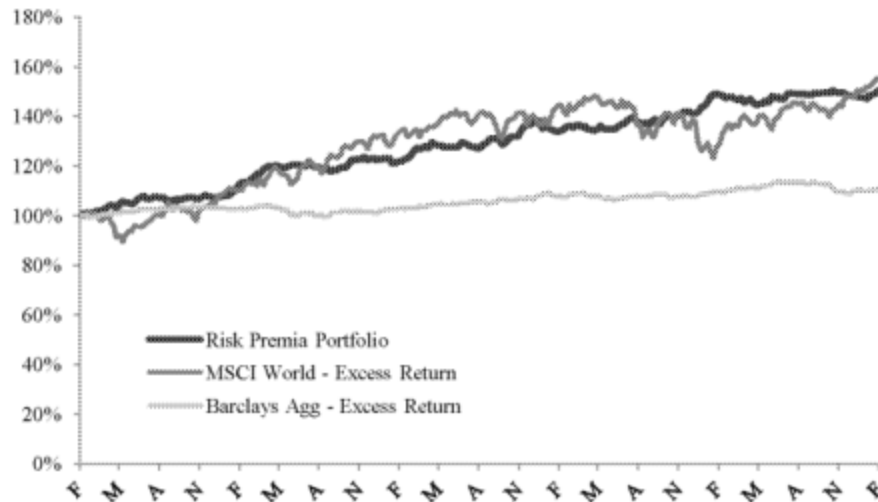

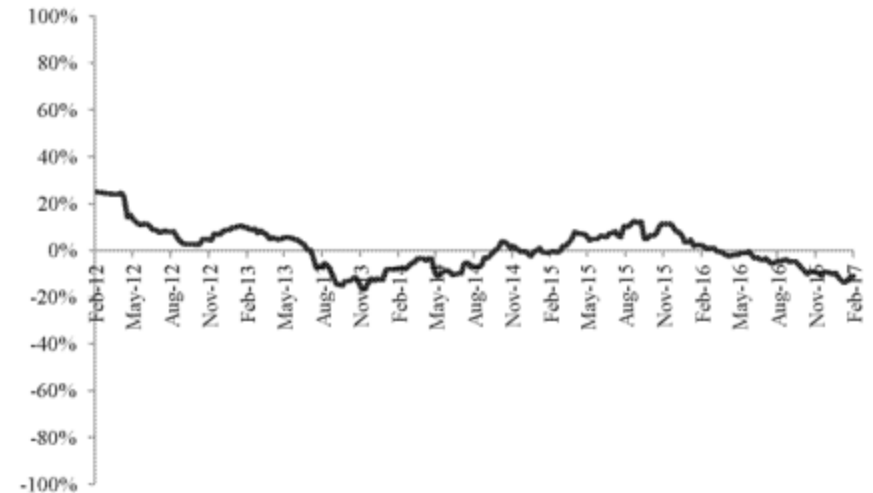
Historical Performance vs MSCI World and Barclays Agg



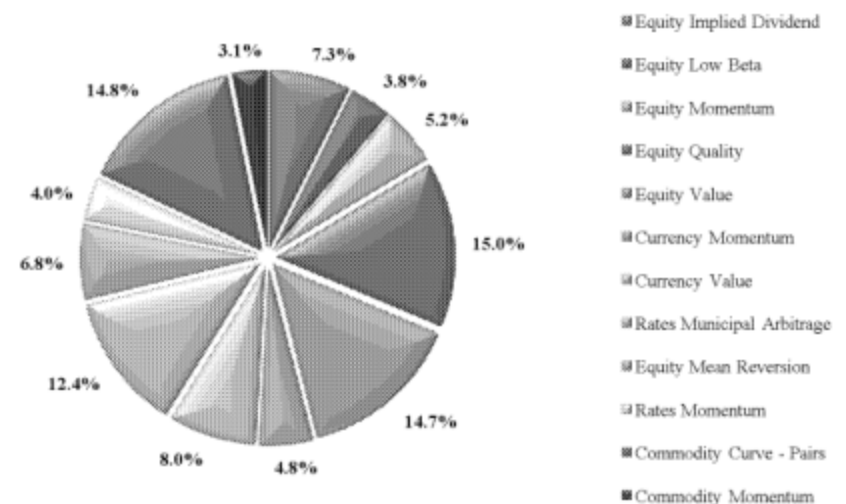
