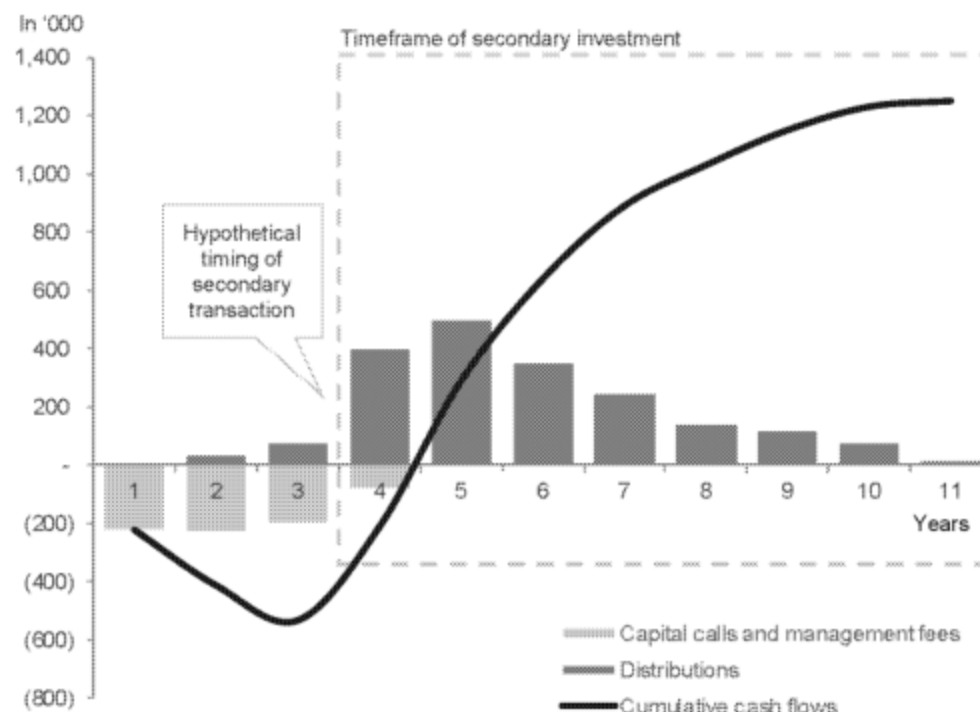


Benefits of secondary private equity investing

Attractiveness of secondary opportunities¹

Pricing Flexibility	- Re-price existing funded assets - Capitalise on pricing inefficiencies
Mitigate Blind Pool Risk	- Knowledge of existing underlying companies - Mature assets typically yield more predictable cash flows
Mitigate J-Curve	- Shorter duration of investments - Earlier cash distributions
Complement Portfolio Construction	- Accelerate deployment of capital - Provides back-seasoned diversified exposure across vintage, strategy, industry and geography
