company ("SilverBay") that was formed in August 2009, which is also registered as an

investment adviser with the SEC. Alkeon's personnel (through SilverBay) manage ACAP

Strategic Fund and Bluepoint Investment Series Trust, both registered investment companies,

and may manage other registered investment funds in the future.

Some of Alkeon's personnel also are registered representatives and employees of Breakwater

Group, LLC ("Breakwater"), a broker-dealer that may be deemed to be affiliated with Alkeon.

Currently, Breakwater assists in the distribution of the ACAP Strategic Fund and Bluepoint

Investment Series Trust and does not have a trading function. Additional information about
