

**NOTICE TO RESIDENTS OF BRAZIL**

THE INTERESTS HAVE NOT BEEN, AND WILL NOT BE, REGISTERED WITH THE SECURITIES AND EXCHANGE COMMISSION OF BRAZIL (*COMISSÃO DE VALORES MOBILIÁRIOS*). THE INTERESTS MAY NOT BE OFFERED OR SOLD IN BRAZIL, EXCEPT IN CIRCUMSTANCES THAT DO NOT CONSTITUTE A PUBLIC OFFERING OR UNAUTHORIZED DISTRIBUTION UNDER BRAZILIAN LAWS AND REGULATIONS. THE INTERESTS ARE NOT BEING OFFERED IN BRAZIL. **NOTICE TO RESIDENTS OF CHILE**
