NOW, THEREFORE BE IT

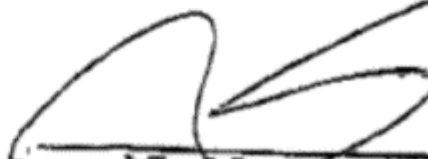
