The federal regulation limits the number of checks, preauthorized transfers and

withdrawals that can be made during a monthly statement period from any savings or money market savings account. The regulations also require us to ensure that withdrawals and/or transfers from these accounts do not exceed the permitted 6 withdrawals per month.

Please be advised that Ms. Maxwell's account [REDACTED] is at 5 withdrawals for the month of May.

The following guidelines serve as a reminder about how these limits apply to your account:

* You are permitted a maximum of six withdrawals or transfers from your

JPMorgan Chase savings or money market savings account as follows:

- o By check, debit card or similar order payable to third parties
- o Overdraft protection advances
- o Any online payments (Bill Pay) and online transfers
