Rød-Larsen came to wide international prominence as a key figure in the 1990s negotiations that led to the Oslo Accords -- the first-ever agreements between Israel and the Palestine Liberation Organization (PLO) -- In 1993, he became the United Nations Special Coordinator in the Occupied Territories at the rank of Under-Secretary-General.

Rød-Larsen then returned to the United Nations, where he again became an Under-Secretary-General, serving as the UN Special Coordinator for the Middle East Peace Process and Personal Representative of the Secretary-General to the Palestine Liberation Organization and the Palestinian Authority from 1999 to 2004.
