Seventy-eight items were examined in case 50D-NY-302751, and their digital examination results exist in archives, loose files and proprietary forensic report tools.

Of the seventy-eight digital evidence items examined, eleven digital evidence items have been inventoried.

From the inventoried digital evidence items the following has been identified:

- 662,402 - photos
- 9,676 - videos
- 217,919 - documents
- 351,696 - emails
- 3 - system reports
- 21,483 - archive files
- 112 - presentations
- 117 - Spreadsheets

Dependent on the format of the examined item additional time may be required to extract and produce the file in human readable format.
