Good Afternoon,

You are receiving this email because you have been identified as working in some capacity with a victim from the Jeffrey Epstein case. Although the indictment against the subject was dismissed due to his suicide, the case is still under active investigation. Over the past month, [REDACTED] has been working to coordinate two victim briefings – one in the Miami Field Office and one in the New York Field Office to be held on October 15 and October 23, respectively. Invitations have been set and [REDACTED] has been tracking responses. We expect to have better numbers by Monday, 10/7.

A few questions for each of you:

- * Your interactions with the victim: how have you supported the victim? Did you meet with her? Provide in-person or telephonic crisis intervention? Provide a resource?
- * Your availability: are you available to support either of the briefings?

* A short list of vetted, trauma-informed therapists in the AOR where the victim you have supported currently lives.
