That is wonderful. I think that the FBI and the prosecutors will definitely want to interview [REDACTED] if we can get her here. She has a vast amount of information and was unfortunately brought over from South Africa to the [REDACTED] a number of times by Epstein and she saw a lot and interacted with a number of people. I would think an interview of [REDACTED] (based on the past interviews I have been in) would last about 2 hours or so. I could try to fly in the NY the day before the meeting and we could do the interview that afternoon on the 22nd if that would work.

[REDACTED] [REDACTED] is coming in for the meeting – she will be driving in the day of the meeting. She may be able to do an interview right after the meeting.

[REDACTED] met with prosecutors briefly but she struggled a bit in the meeting and we had limited time so her interview was not completed. Not sure if they would like to reschedule that interview but I know she plans to come to the meeting. We could try to do that the day before on the 22nd as well if that would work.
