Hi all,

After speaking to ACS, it appears all they would really be able to provide is a list of English speaking doctors... not necessarily the best or anything of that nature. Inasmuch as she lives here.. and unknown to me, but presumably she speaks Spanish, this may not be the best option.

I recommend the following:

██████████, can you reach out direct and speak to the victim to talk through a few things:

1. Where exactly does she live? This will matter because the list of doctors is mostly Madrid and Barcelona centric.
2. Does she need an English speaking doctor, or is she comfortable enough speaking Spanish.
3. Would she like the list or does she have her own doctor and is only looking to see what exactly we offer.
4. If I understand correctly, our services are a. getting her a list and b. advising how many sessions we pay for etc.
5. It needs to be said that the list is only a list of english speaking doctors, while it implies "embassy approved", many of these doctors the embassy knows very little about.. so they aren't endorsing these, the embassy is simply advising they speak english, just want her to understand that part of it.

So, ██████████ can you reach out direct please. Her email is below but I don't see a number, but looking at the string she obviously spoke with ██████████ in NY. Perhaps she has a #.
