

Brand, 49, was earlier this month charged with one count of rape, one count of indecent assault, one count of oral rape and two counts of sexual assault, allegedly committed between 1999 and 2005 against four separate women.

The alleged offences are said to have taken place in Bournemouth and the Westminster area of London.

The Metropolitan Police began investigating Brand in September 2023 after a number of allegations were first reported by Channel 4's Dispatches and The Sunday Times.

He moved to the US last year with his wife, Laura Gallacher – sister of TV presenter Kirsty – and their three young children, claiming it was because he had become an 'inconvenience' to the 'media, government and judiciary' in Britain.
