On 26 March 2024, you appeared as a guest on the 'Dan Wootton Outspoken' show where you stated:

"I'm waiting for George Tonks to be able to speak first. He gets off his probation at the end of May and then a lot will be revealed then. He's the other witness who is on a gag order by a judge right now in Chicago who has a lot of incriminating evidence about [REDACTED]"

"Susannah Reid had a complete meltdown when I said that these girls were con artist liars. The fact is that I have never received one legal letter from anybody because, you know what, they don't want me in court."

"I have emails where [REDACTED] says in an email David Boies doesn't think that I can stand up in court. These girls are not reliable witnesses."

Our client understandably finds your allegations deeply upsetting. She has already had to endure many years of pain whilst coming to terms with the abuse to which she and her sister were subjected, and your false allegations have only served to exacerbate her trauma and suffering in this regard. Our client finds it extremely hurtful and offensive that you have repeatedly sought to gainsay her own account without any proper evidence. Mr Tonks is unable to provide any first-hand evidence in relation to the abuse our client endured and his previous actions, as described above, make him a highly dubious witness in any event.

Resolution

Our client is entitled to seek substantial damages for the injury to her reputation, in vindication of her good name and to compensate her for the distress and injury to feelings she has suffered in consequence of your unlawful conduct outlined above. She is also entitled to seek injunctive relief and/or a compliance order under section 167 of the DPA requiring your removal of the offending statements and to refrain from making the same, or similar, statements in the future. The injunction would also prevent you from otherwise harassing our client and she would be entitled to an order requiring you to publish any judgment finding that she has been defamed. Finally, our client is also entitled to seek her legal costs from you.

Notwithstanding our client's unquestionable entitlement to the remedies mentioned above, her primary concern is to ensure that any content that you have published about her which remains online is removed immediately, you retract and apologise for what you have done, and your unlawful conduct ceases forthwith.

In the circumstances, our client requires that within 14 days of this letter (i.e. by 4.00pm on 23 April 2024) you:-

- 1) remove all online content in which you refer, directly or indirectly, to our client;
- 2) undertake in writing (to media@brettwilson.co.uk) that you will NOT repeat the allegations complained of, or any similar

oppressive behaviour, resulted in our client severing ties with him.

Since our client distanced herself from Mr Tonks, he has taken it upon himself to traduce her good name through an online smear campaign which has caused her unwarranted damage and distress.


Mr Tonks' main allegations against our client have been summarised in an article headed 'Exposing [REDACTED]' (referred to in your online publications) under the sub-heading 'Tonk's Claims', some of which have been repeated in bold text below for ease of reference. We briefly explain the true position in respect of the statements from the article which relate to our client and concern the imputations complained of and aver that, in light of the facts and matters outlined below, you will not be able to discharge the evidential burden in the present case, notwithstanding your protestations that you have "undeniable proof" of our client's wrongdoing:-

- 1) "[REDACTED] never filed an FBI report in 1996, as she has claimed for years."

Our client did in fact file an FBI report in 1996 and this, as you know, forms the basis for an ongoing legal action that our client has brought against the FBI for its failure to act appropriately upon receiving the report. James Hill, a producer at ABC, submitted a Freedom of Information Act request to the FBI and received a redacted version of our client's interview with the FBI in 2006 concerning what had happened to our client in 1996. The transcript of this interview refers to our client's previous report in 1996.

- 2) "The only police report on file is [REDACTED] reporting Epstein for burning her art"

As indicated above, when our client made her report to the NYPD in 1996, they said the only offences for which they had jurisdiction were those committed within New York and recommended that our client reported what happened at Mr
