Chemotherapy regimens such as CHOP, MOPP, and ABVD that include the alkylating agent cyclophosphamide, procarbazine, nitrogen mustard, and dacarbazine, and the anthracycline doxorubicin found in CHOP and ABVD are also linked to late health effects including infertility, gonadal dysfunction, a decrease in cardiac ...

Infertility:

ABVD can damage the ovaries in women and testicles in men, potentially leading to infertility. [🔗](#)

Cardiomyopathy:






Cognitive and Neurological Effects:

Memory and Learning:

Radiation can damage healthy brain tissue, leading to difficulties with learning and memory, particularly if the hippocampus, a brain region crucial for memory formation, is affected. 

Cognitive Decline:

Radiation-induced cognitive decline (RICD) is a common late effect, impacting attention, working memory, and information processing speed. 

Neurological Deficits:

Brainstem injury can result in cranial nerve neuropathies, potentially causing permanent neurological deficits, including problems with vision, hearing, and movement. 

Increased Intracranial Pressure:

Swelling or inflammation in the brain can increase pressure, leading to headaches, nausea, and seizures. 

Physical Effects:

- **Fatigue:** A very common side effect of radiation therapy, fatigue can be severe and persistent, impacting daily activities. 
- **Skin Changes:** Radiation can cause skin changes, including redness, dryness, and scarring, with increased sensitivity to sunlight. 
- **Hair Loss:** Radiation to the head can cause hair loss in the treated area, but hair usually regrows. 
- **Swelling and Scarring:** Soft tissue and muscles can develop scar tissue and/or shrink, leading to reduced flexibility and increased chronic swelling in the treated area.

Common Short-Term Side Effects:

Hair Loss:

Low Blood Counts:

During chemotherapy for stage 3 lymphoma, just following brain radiation surgery for a separate cancer/brain tumor, just after being SAd by my own council...Sigrid McCawley and David BOIES FORCED ME to file the affidavit which initiated Epstein's arrest.
