



On 26 March 2024, you appeared as a guest on the 'Dan Wootton Outspoken' show where you stated:

"I'm waiting for George Tonks to be able to speak first. He gets off his probation at the end of May and then a lot will be revealed then. He's the other witness who is on a gag order by a judge right now in Chicago who has a lot of incriminating evidence about Virginia Giuffre and Maria Farmer."

"Susannah Reid had a complete meltdown when I said that these girls were con artist liars. The fact is that I have never received one legal letter from anybody because, you know what, they don't want me in court."

"I have emails where Maria Farmer says in an email David Boies doesn't think that I can stand up in court. These girls are not reliable witnesses."

Our client understandably finds your allegations deeply upsetting. She has already had to endure many years of pain whilst coming to terms with the abuse to which she and her sister were subjected, and your false allegations have only served to exacerbate her trauma and suffering in this regard. Our client finds it extremely hurtful and offensive that you have repeatedly sought to gainsay her own account without any proper evidence. Mr Tonks is unable to provide any first-hand evidence in relation to the abuse our client endured and his previous actions, as described above, make him a highly dubious witness in any event.

Resolution

Our client is entitled to seek substantial damages for the injury to her reputation, in vindication of her good name and to compensate her for the distress and injury to feelings she has suffered in consequence of your unlawful conduct outlined above. She is also entitled to seek injunctive relief and/or a compliance order under section 167 of the DPA requiring your removal of the offending statements and to refrain from making the same, or similar, statements in the future. The injunction would also prevent you from otherwise harassing our client and she would be entitled to an order requiring you to publish any judgment finding that she has been defamed. Finally, our client is also entitled to seek her legal costs from you.


Notwithstanding our client's unquestionable entitlement to the remedies mentioned above, her primary concern is to ensure that any content that you have published about her which remains online is removed immediately, you retract and apologise for what you have done, and your unlawful conduct ceases forthwith.

In the circumstances, our client requires that within 14 days of this letter (i.e. by 4.00pm on 23 April 2024) you:-

- 1) remove all online content in which you refer, directly or indirectly, to our client;
- 2) undertake in writing (to media@brettwilson.co.uk) that you will NOT repeat the allegations complained of, or any similar

Several I love feel this way as well. It is entirely unacceptable to reside near ppl who normalize genocide and child harm. White Evangelicals do this. You have no compassion for those whom you used to redeem yourself over what you did to Rose McGowan. David I'm certain you used Black Cube or some form of systemic abuse against me as well! You counted on the fact that because I'm not a celebrity, no one cares about me. How on earth could you "accidentally" not compensate me out of \$375 mil, when you used me to get this entire case started?
