On 9/23/2021, at 9:58 AM Eastern Time, [REDACTED], date of birth [REDACTED], Cell telephone number [REDACTED], Residential zip code 19124, called the FBI National Threat Operations Center (NTOC) to report additional information concerning possible victim of Jeffrey Epstein & Ghislaine Maxwell in New York, NY.

[REDACTED] provided the following information:

[REDACTED] was a victim of Jeffrey Epstein & Ghislaine Maxwell, in NY in the mid 1990s. [REDACTED] met Maxwell and Epstein in approximately 1994. [REDACTED] was a student at the Fashion Institute of Technology at NYC. [REDACTED] also worked at Henri Bendel at 5th Avenue, which was/is owned by the CEO of The Limited at the time. [REDACTED] met Maxwell as a client working there. The day [REDACTED] met Maxwell, the two became friends and [REDACTED] delivered Maxwell's packages to the St. Regis hotel. [REDACTED] was introduced to Epstein there and was assaulted there. Maxwell said her boss was friendly with Mr. Wexler and she wanted [REDACTED] to meet him. When [REDACTED] arrived at the hotel, the concierge told [REDACTED] to go to the bar because Maxwell wanted her to meet someone. [REDACTED] met Mr. Wexler. Maxwell used the terms 'boyfriend' and 'boss' sometimes like they were separate people and sometimes like they were the same person. [REDACTED] had a drink and the concierge said her room was ready. [REDACTED] was confused. That night, [REDACTED] brought the packages in the room and was assaulted. At some point, Epstein went into the bathroom and put on a bathrobe. Maxwell and Epstein made out and tried to get [REDACTED] to join them. Maxwell put her hands on Epstein's penis, started to masturbate him, and tried to get [REDACTED] to join. [REDACTED] felt pressure and joined in. [REDACTED] got freaked out by the situation and exited the hotel room to meet her boyfriend without being raped. After that night, weird things happened at work. [REDACTED] was offered a position created out of thin air. At the time, [REDACTED] wanted to go to law school and taking that job would mean she had to leave school one semester short of getting her degree. [REDACTED] said no. Maxwell had something to do with the position and was upset [REDACTED] did not take it. [REDACTED] quit her job at Henri Bendel

after graduation and worked for a clothing manufacturer at Bloomingdales. Maxwell showed up looking for █████ and found her. Maxwell pushed a friendship with █████. █████ was first assaulted in 1995. █████ was assaulted a second time at a New Years Eve party at a hotel in 1995. █████ did not know the date or time of the third assault. █████ directly recalled three assaults. After the second or third assault, █████ completely dissociated. Maxwell and Epstein convinced █████ to dump her boyfriend, go to the New Years Eve party, and got raped by Maxwell, Epstein, and her date. █████ ran out of the hotel in just her evening gown to get away from them. Maxwell and Epstein found █████ again "a couple weeks" after. In January 1996, █████ went to FL with Maxwell and Epstein at their request and was raped by them and several of their friends. When █████ got back from FL, Maxwell and Epstein trafficked her for their friends under the guise of setting her up with their friends. █████ involvement with Maxwell and Epstein ended in late 1996 or 1997 when she had a nervous breakdown. █████ moved three times to get away from Maxwell and Epstein.
