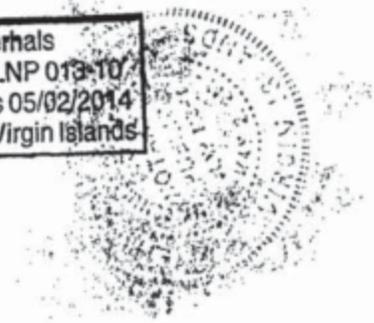

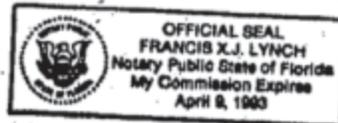

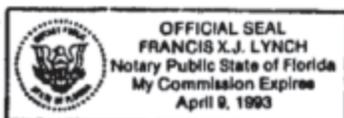

AGREEMENT

THIS AGREEMENT, made and entered into this 10th day of JANUARY, 2002, by and between Jeffrey E. Epstein, hereinafter referred to as Owner, and the TOWN OF PALM BEACH, Palm Beach, Florida, hereinafter referred to as Town.

WITNESSETH:

WHEREAS, Owner owns a residence in the Town of Palm Beach, Palm Beach County, Florida, situate at 358 El Brillo Way, located in "R-A RESIDENTIAL DISTRICT", the legal description of which is attached hereto as Exhibit "A"; and

WHEREAS, Owner has applied to the Town Council of the Town of Palm Beach, by application for Special Exception #24-2001, for permission to install a kitchen in an attached accessory building for the use of Owner's family and his bona fide guests; and

WHEREAS, the Town council of the Town of Palm Beach has approved the granting of said Special Exception #24-2001, upon certain conditions hereinafter set forth, which said conditions are acceptable to Owner;

NOW, THEREFORE, in consideration of the premises, it is agreed by and between the parties, as follows:

1. Upon the happening of any one of the following events, the kitchen to be installed pursuant to Special Exception #24-2001, shall be mandatorily removed at the expense of the Owner or his heirs, successors or assigns, to wit:

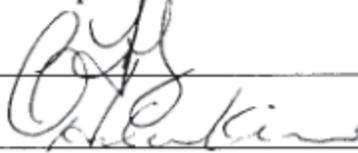
- (a) Upon the above described premises or any portion thereof being rented.
- (b) Upon the said kitchen facilities being used for purposes other than for the use of bona fide family members, household staff and non-paying guests of the Owners.
- (c) Upon the premises being sold without the purchaser of the premises applying for, and being granted, a renewal of Special Exception #24-2001, and agreeing to be bound by the terms and conditions imposed thereon by Town. If the purchaser agrees to be bound by the terms and conditions expressed in this Agreement, said renewal of Special Exception #24-2001, shall not be unreasonably withheld by Town.

2. Upon the failure of the Owner or someone in his behalf to comply with the requirements of Paragraph 1 above, Town shall have full right and authority to enter the above described premises, remove the kitchen facilities and assess the cost thereof against the lands hereinabove described, regardless of the ownership of said lands at the time of the removal of said kitchen facilities.

3. The Owner does hereby agree that the proper Town officials may inspect the property to ascertain continuing single family use should any question arise as to this use and, further, the Owner will send to the Town an annual written statement to confirm that said single family use of the property is continuing and there is a need for the aforesaid second kitchen.

4. This Agreement shall be recorded in the Public Records of Palm Beach County, Florida, and such shall constitute notice to all persons whomsoever of the terms and provisions hereinabove set forth.
