

Things we learned today, thank you for clarifying:

1. On one of the haddrives you've populated for us, this is the breakdown.



2. The disk called "1b1 copy thumbdrive from K&L Gates 9/29/2020" is the same as 1B1 on the harddrive, but exported from the FTK imager. The disk version is better to give to defense.

Things that we need to tackle on Thursday, by repopulating the SDNY drive:

1. the CD called "working copy of emails" that initially had on it a sticky labelled "1b8" is not 1b8. It might be 1b2.
