According to the Palm Beach Daily News, the state change of plea has been reset for March. The NY Times called our office yesterday asking for comment on specific issues (insinuating that [REDACTED] all have ulterior motives for the investigation/prosecution). The Office has not yet decided whether it wants to issue a press release or not, but I am putting together some info for them.

I did find the letter from Reiter to the victims. During our last meeting with the defense (on Monday), we offered a federal plea, and I have prepared a federal plea agreement and provided it to [REDACTED]. They have not yet heard back from defense counsel.
