Chronology:

- GM born in France in 1961, suburbs of Paris, raised in England, 9th + youngest child of Robert Maxwell
- Debut, too small, don't co., worked for father's co., 1991 talks expanding to US, GM emg to US, Co. collapses, "vestibule" in US → meets JE shortly before death in 1991. CEO of Bar Stern tells her JE is "white"
- "insophisticated" in realm of relationships
- 1991 - GM began helping JE because of her marriage to Simon
- Nov. 1991 - GM reconnects w/ JE + becomes "Alicia"
- Nov 91 White House state, JE "damned" prospect of celebrity
- 1992 JE + GM intimate for first time
- JE "compartmentalized" + "combined off" GM from almost all jobs since
- GM "was allowed" to look @ message sheets or pager phones, JE had other girlfriends. But GM thought her job as JE "public face" had normal
- (JE personally w/ [redacted])
- mid-90s, noticed "changes" in JE behavior, seeing her less than before (maybe half a day or month), partly estimate about eye per month
- mid-90s, GM in charge of managing JE's properties - "very demanding" role
- JE went through 3 or 4 managers, 6 or 7, kept firing + hiring them
- GM making a salary from it, gives JE weekly reports, travels into properties
- 1996 home accidents
- [redacted]
- GM is "the last person" JE would have involved in ~~sexual~~ sexual matters
- GM wanted to have a child w/ JE
- GM has a medical condition making allegations re sex w/ maxis difficult to be physically possible, though could be intimate w/ JE just not every day
- biologically very important in securing maxis for sex w/ JE
- late 90s (GM in late 30s), JE says maxis says her best will have child w/ her
- GM stayed for child even though relationship deteriorating
- JE starts using testosterone pills, which make her more aggressive, 97/98 stopped sleeping in room w/ JE
- 99 or 2000, stops having sex w/ JE, JE w/ [redacted]
- around 9/11 GM break from JE + GM takes other men
- ends romantic relationship
- 2003, GM takes Ted Lyle (Exterior Painter) [redacted] '03 - 10
- very serious + committed
- GM about JE for large chunks of time
- spends less time than JE

- '01-'02 → GM trying to eradicate Lesell from JE professionally
- '01 [redacted] came into mix + meet in [redacted]
- GM thought [redacted] would work for GM to replace [redacted]
- after in NY, JE says [redacted] will work for JE not GM
- GM educated [redacted] re managing home + Dea = [redacted] take over
- [redacted] gets GMS books @ NY [redacted] residence
- '02-'05 → GM only traveling w/ JE for business reasons
- fighting w/ JE, but keep around b/c JE wants GM in her role
- '04 JE mother had medical emergency, GM went for her great deal
- GM stayed to help w/ mother
- JE asks for help w/ mount properties, but schedule her own + GM could opt out
- GM's mother was financially dependent on GM

- '01-'03 = when assaults reported to have took place
- meets [redacted] around '02 or '03, doesn't recall meeting [redacted]
- [redacted] blaming [redacted]
- recalls speaking w/ [redacted] on phone

- '05 PB residence raided
- GM not involved in FL investigation, no one contacted her, she didn't have answers, wasn't a target
- [redacted] appears to spot flow of girls + recruitment, for [redacted]
- GM mentioned 3x in PB reports, but not implicated
- '08 JE in jail, GM didn't visit, understood to be see w/ "underage prostitute"

- long relationship, JE asked GM to connect w/ bunch of professionals, including massage therapist
- only about [redacted]
- bunch one was [redacted] (late 20s) professional
- GM recalls JE getting 1 massage per day
- "for her, massage is massage"

- [redacted] case → GM testified, didn't make
 - [redacted] testified, didn't make

- 2009 = first allegations against GM from [redacted]
 [redacted] contacted by PSPD but declines to cooperate
 files lawsuit May 2009 alleges GM abuse
 → GM + JZ breakup
 → GM being TD being blackmailed into settling
 - BE is part of Redstein's firm @ some time

- early 2011 - [redacted] interviewed by Daily Mail
 - author encouraged [redacted] to accuse others
 - Charles contacted [redacted] through father, [redacted] then reached out to Charles + asks for \$ for article
 - Charles sends email a hour before Beth
 - [redacted] asks to remind who he talked about
 - Charles later fired
 - BE makes tel [redacted] to "anything to spread [redacted]"
 - access all BE clients

- [redacted] "reliability issues"
 - allegations has no resemblance to other reasons, claim GM breached [redacted] to [redacted] former

- [redacted] admitted in deposition that made up certain holes
 reliability issues
 GM + JZ + [redacted] all intimate together on multiple occasions
 - never called by GM to recruit
 - only saw GM a few times
 - Alessi U to Spitzer + change → don't support knowledge of GM
 - Alessi - '91 - '102, but none of any messages mbr of
 - Emilio Razo (Orbion brother) - GM, JZ, 15 yo. girl → 15 yo. tells Razo
 prospect taken for her
 - Razo never reported + kept looking for Orbion
 - Razo ultimately fired

- 2012 civil suit against JZ + GM
 alleged Oct 2006 [redacted] recruited
 - allege GM + JZ hired her to submit compliance demands → 22 yo.
 - didn't reach GM til 3 mos after rec'd JZ + had sex w/ JZ
 - caught as part of Spitzer probe, mg
 - told NY Post reporter had sex topics, but later concludes she made them
 eye to know deception to JZ

[redacted] affidavit Apr 2019 re Ohio sexual assault + GM inappropriate w/ [redacted], spoke w/ NYT + WaPo

- only ones aware of in 1990s + only ones alleging GM inappropriate
[redacted] JS, Engstrom denies [redacted] recording re assault, [redacted] story changed

[redacted] ranch visit, GM misinterpreting phrase was to be [redacted] by [redacted]

* [redacted] reports in ranch Apr 1996, flight logs show GM never in NM in Apr 1996

- GM denies these allegations
- GM only denies sex w/ JE to most females, not sex w/ adult females + JE

- rape w/ [redacted] around '01 or '02, doesn't claim met GM, only upon info shared

- NPR interview + Brian Long, not through message teacher

- 21 who met JE

- account confirms adult massage from legit massage school

- didn't allow GM know anything, behind behind GM back

- also 2015 [redacted] interview -> said never had sex w/ JE, so inconsistent
