This is my testimony of the ~~year~~ ^{summer} of 1967. My last year of high school. I just completely recovered this memory.

My time in New Jersey was so bad, I told my father and then deleted it all from memory. My father sent investigators to Seaside Heights New Jersey and found what I told to be true including all the guns and ammunition stashed in his house, the claw marks where I had clawed my way out of that room I was locked in.

This is my testimony.

I was attending high ^{school} in Nashville when my oldest brother Raymond Meritt was returned from Vietnam and released early (discharged early) and told no one in his family he was back in the states.

He came out to my school and hooked me, caused the kids to become addicts and sent George McDovitt to get me with him the idea being to sell me to Jeffrey Epstein since, it being said because I am religious the Saudi's might buy me - they

like religious girls,

I got pregnant very quickly. We married April 8th ¹⁹⁶⁷ and I was 2 1/2 months pregnant when we arrived first part of June 1967. It was the mother on me that caused me to fight so hard, to ^{get} out of there,

I had a younger brother named Donald that I nicknamed Donk, and when George saw him he kept picking up a bull calf. I said Donk what you doing? and he said, Kenny (his friends) has weights, I don't have ^{any} so I am building my muscles with this bull calf.

My little sister was carrying around a bunny ~~and~~ rabbit like Ellie Mae. My mother was protective of me saying no man is going to live with my daughter not married to her. My father's footsteps made the whole house shake. George said he ~~sounded~~ sounded like a giant.

Then a cow trotted him and he trying to ~~run~~ run from her got hung up on the barbed wire when paddle foot the mean goose chased him. Come to find out later he had ^(my dad's animals didn't like him) not intended to marry me, but my mother

threatening him with a shot gun scared him so he rushed me to ^{the} alter

Then we immediately left for New Jersey. We get to New Jersey very shortly I was shot up with heroin.

Now comes the testimony about Trump and Epstein.

The plan had not been to get me pregnant and marry me but to sell me to the Epstein bunch through Donald Trump (Raymond also getting a cut)

Seage's father was Chief McDevitt of Seaside Heights, New Jersey. He had all these secret panels, guns and ammunition ~~at~~ stored in his house.

From the memory I have on the day Donald Trump passed by they must have had me in Chief McDevitt's bedroom, and placed where with these panels open and the ~~garage~~ garage door up Donald Trump did not have to step foot in the McDevitt home.

These panels were open and the garage door up, ~~and~~ and Chief McDevitt's ~~bed~~ bed moved over so

Donald Trump can stand in the driver way and have a clear view of me naked and on my knees on the mattress.

Donald Trump says you said she is pregnant, she doesn't look pregnant. George says she is. My ~~dad~~ dad took her to Army Doctor and he estimated she is 2 1/2 months pregnant. Trump asks is she on drugs, George said yes. Trump said, we don't like for them to be pregnant because we lose money. A doctor might could cause her to miscarry or if the child is good looking whether we could sell the baby. You said she is religious the Saudi's like the religious ones. We'll figure it out, you will take her.

George's first cousin worked for the Trump organization. He said I want her before she ~~goes~~ goes. I put up my feet to stop him, he ran into my foot and my toenail sliced across one of his balls and he fell on the floor screaming. Donald shouted, Deals off we won't take violent females, ~~and the~~ ~~departed~~, Deals off. George shouted

what do we do with her? Trump shouted, day six, feed her to the fishes. I don't care what you do with ~~her~~ her.

They locked me in George's bedroom, threw some syringes in the room, and left me with no access to food, water bathroom, etc. and departed. Also no air condition. This Jewish family lived next and their son was trying to get help for me, and he was killed,

The first thing I did is emptied all the drug syringes onto the carpet. When I needed to urinate, I did so on the carpet, when I needed to poop I did so on the carpet.

Then I apologized to the Lord about forgetting to pray and started praying and I started getting out of them. I used my high heel to break through the drywall into the chief's closet and access to bathroom and food. When they returned expecting to find me dead, I was alive and they had one can of beans left in their cabinet.

They locked me back in George's bedroom by boarding up the ~~door~~ ^{door} and

closets

George was looking out the front picture window when I asked the Land to break me out of here. I want to go home.

This Jewish family next door, their son was trying to help me, and they must have given him something crazy because he fell through a second floor window and fell to his death.

George left the ^{outside} door unlocked when I touched the door to ~~door~~ George's bedroom, and this force went through my ~~hand~~ hand and the door fell off ~~to~~ its hinges and fell on the floor.

A storm named Tropical Storm Donnel was coming in. The weather said it had come up from Jamaica went to the east coast and was ~~aimed~~ ^{aimed} straight at Seaside Heights, and coming with the force it had it would decimate Seaside Heights.

I left the McDevitt house behind George and went down to the boardwalk. I walked out to the end of the pier, with the wind blowing so hard I could hardly stand up. I told the Land I have

gather myself into a mess, please send my brother down to help me. I was referring to Albut, but because of the storm have the name of Donelle they thought it was my younger brother come to rescue me.

~~This~~ This whirling of wind and water appeared before me on the ~~storm~~ stormy water and out, it came the words - "you will be delved."

I ran back up the boardwalk, it was falling in behind me. I could ~~feel~~ ^{feel} the shaking and hear it falling. I ~~saw~~ saw this man, and shouted "jump!" He did, and when he had been standing full in the water. He said I turned into an angel. No it was the Lord's word ~~giving~~ ~~shining~~ shining in me.

I go back to the McDermott house, call Chief McDermott and said - I want \$150 and a ride to the airport here at 7:00 A.M. He said I don't have \$150 cash on me. I said I don't care how you get it. Tomorrow at 7:00 A.M. a ride and \$150, if you don't my brother is coming up here and tear apart your whole town.

The next morning at 7:00 A.M. a Police officer arrived, gave me the \$150 in cash, and said someone has to save our town so I stepped forward to drive you out of here.

He drove me up the Coast and the storm followed ^{up}. He dropped me off at a police station and the storm came there and scared them so I was driven to Fort Dix and put on a ~~helicopter~~ helicopter and flown to New York. ^{D.F.K. Airport}

Trump was on that helicopter and he asked me how George got out of the service ^{and} ~~etc~~ I told his father bribed the senator who now put ^{me} ~~me~~ on this National Guard Helicopter to fly me out of here to New York. By 4:00 o'clock that afternoon my plane landed in Nashville, TN.

I spent the night at the school, the next morning was driven to the bus station and caught a bus to Dover, TN, walked to the sewing factory and caught a ride home.

I had called my Aunt Leila in Alabama, and she had sent a letter to my mother and my mother called

the Chief in Seaside Heights to check on me, and he told Don't ever let Phyllis out of Tennessee again when she gets when she can see for a long ways, she turns into a one person demolition squad.

These people here didn't know that and that's why they placed on the 10th floor of a senior housing bldg.

My father when he saw me by myself - He said what happened to you up there? You look like a truck ran over you.

I told him what happened and he and some feds he worked with went up there and Chief was fired, he died with every thing gone all staying at his daughters home and George was put in prison for two years. (in California)

I need witness protection

Raymond has given another woman my name, she's a Yugoslavian prostitute whom she lives at [REDACTED]

[REDACTED] They also gave her my social security # This woman is about stealing the money that belongs to the wife of Jerry Albert

and when she recovered the memory she filed charges against Raymond Morris and tried to find the dark haired woman wearing glasses and driving ~~Yellow~~^{Checker} Cab 25.

My daughter let Raymond in my house and he threatened if I tried to testify on her behalf he will kill me.

I knew he meant it and had he not come to threaten me I wouldn't have known the woman tried to find me July

I purchased the house in 2004. I quit driving in ~~1995~~¹⁹⁹⁵. People recover the memories of the knockout drug usually 10 or 12 years later — that would have been filed probably 2005 or 2006 with Metro Police (Nashville)

She was accusing Raymond and needed my testimony, he got inside my house at night because my daughter gave him the remote to my garage door. as drugging her

to pinpoint this closer when I found my daughter she had taken one of my garage door remotes and I filed a complaint with Wilson County Sheriff's office. The remote was brought back to me but in between there is when I woke up with Raymond beside my bed choking me out threatening not to testify (possible summer 2007 or 2008) against him

When I was ^{sharing an apartment} staying with my brother Donald Morris back in early 1990's. He wanted me to have sex with him and I refused (in the word of God its called incest). He took me to this place in Lausanne and sold me as a sex slave, even though I was 45 years old they purchased me,

Then he paid them to have sex with me. I despised him for this and I laughed and mocked his teeny weenie - Look its skinning up into its turtle shell - HA, HA teeny weenie is ashamed to show his face. Ah teeny weenie peek out at me so I can have a good laugh.

He was going to hit me and they don't allow the females to be bruised. And they don't want ones that make fun of the male clients.

They looked up who sold me to them and it was him. They made him give back their money and take me with him. Now they were afraid it was a set up and wouldn't allow Donald back in.

They told Raymond because it was one of his operations. He received protection money from them. They did shut it down and move it - Raymond telling she is a squealer I'm afraid she may know some who worked with our dad, and they will believe her. He was also

afraid I might know some of the females because they ^{were} one who had worked with me and went out with him because he was my brother. That's when I developed a habit of not making girl friends.

None of the girls had on makeup, hair fixed or clothes on, so no I didn't recognize any. I told Clyde Hughes with FBI about it and when he got there warehouse was empty.

Prior to driving a taxi I had worked for UPS in their main office,

There was a woman there who went out with him because he was my brother. She was thinking about wedding bells & trusted him. He raped her twelve year old daughter and threatened if she told on him he could have human services take her daughter away from her. I told her I am so sorry if you had told me - I would have told you he can't marry you. He has a wife & two kids in East Tennessee. Another girl friend at Vanderbilt University she raped her behind a club and left her naked behind it (and he raped

Toward latter part of my driving for yellow cab Raymond abducted me and my cab - he and this other agent knocked me on back of my head and carried me to Raymond Lino white the female with the drug dogs drove my car.

Raymond took me to the FBI building and was raping me, and offering me to the other FBI agents. The only ones of the other FBI agents who came up close to me was the short blond hair one I've seen among orthodox Jews and the female and male ~~both~~^{both} of the drug dog agents.

Now Raymond is hanging out among and has the orthodox Jews buying and selling drugs and knowing him he is raping every female Jewish woman he believes he can cause no one to believe her.

This I am just saying because your dad was similar in ways to mine.

I got home + mom worries if she taught^{me} how to be a wife.

My dad is quiet until mother leaves the room. He says, what happened in Jersey? I looked at him in surprise he said. Every time your mother looks away you start shaking, your face is pale and I see the needles on your arm what kind of addiction are you coming off of. I said they used the word heroin he said O.M.G. People don't ~~start~~ start with that, they end up there.

I held out both arms and said do you notice any thing? He said, your left handed you weren't the one shooting yourself up. I said thank you. For a while I thought my body is all my parents mistakes. I knew momma wouldn't know and I prayed my dad's investigator mind will catch this.

My dad told my mother so she would ~~stop~~ stop thinking she didn't teach me how to be a wife. He said who did it? I said Nick. His sister's husband, he works at Catholic Clinic for addicts. They do a lot of experimenting on people. It was not expected I'd make it home. I broke a bunch of stuff. So I was taken to Nick's mother's

This is why the woman never wanted to speak to me again nor bother my husband.

I asked her how old are you? she said 34. I asked ever been married? she said no. I asked engaged? she said no. I said honey you need to get your own husband while you still have some looks. Jerry says I have been married 14 years. I was 20 years old when he asked me to marry him.

At first it is sex and looks but it takes more than that to keep a man. Just recently Jerry said when I turn the corner at Moss Lane and see the lights of home it feels so good to me.

When I walk up the ~~door~~ sidewalk, no bell collect or jump out at me and no men coming running out the windows.

I open my door and my kids are clean and watching TV or playing Atari. I can smell my supper cooking on the stove. It feels so good to be home.

When Jerry says I know what I have with you. This is what's he's talking about. Yes sex is still there but what's most important is the comfort of home. *Forever*

Remember when you contacted me before and these strange things started happening. It was at the time of Covid. I think the person behind that was Joseph LaRue - hence Raymond Marie?

Joseph LaRue is a black man that worked and retired from FBI - Raymond Marie taught him some CIA things -

^{Joseph}~~Joseph~~ has followed me where ever I go ~~to~~ in Alabama to every ~~of~~ apartment and it was black persons doing strange things to me for example taking the ~~heart~~ ^{heart} away, my insurance company wanted ^{the nurse} making the bank so tight it ~~for~~ hurt which raises blood pressure. He came back asking she didn't open the door? This woman said no. She said she wished these people would leave outside her door because they are making her dog bark and she is concerned about

I don't remember the words my family spoke I just remember they said a bunch of hurtful words like arrows in my heart.

The end result was they died in my heart. Their words hurt and I couldn't think about them or remember things that endeared them to me. The result was no hurt, no pain, no pleasant memories of ^{or} unpleasant memories - just nothing. They died in my heart. I also am not full of hurt, thoughts of revenge or feel a need to speak anything to them, other than I want my money.

That wasn't my family here
yesterday it was the other Shaw's

I remember at the first hearing this

but don't know all the kids
what had happened in my phone
was cloned when I said something

Just mentioning if she alive might be
The persons who lived beside the ^{Witness of these things}

New York. He was a Jew who escaped the

because he was trying to help me, the other
son was an attorney in New York City.
~~He had~~ The young attorney son had a daughter
Approximately 5 years old, They had come
in for the funeral of the one that was

I tapped on the McDevitt picture window
to get her attention and told them to park
in McDevitt driveway. She got her father's
attention and I motioned to him park here.

He came over that evening to thank the

my left arm and shut down but he might

I am left-handed if I had done this the tracks

She would if alive remember her

judgement. Friends I had trusted and loved
became addicts and I can't stand addicts

A boy I had a crush on for several years,
we were talking about college. He seemed
like a decent person and that he had gotten
the ^{girl} drug and tells another boy this
girl will have sex with him for a nickel.
~~The boys~~ says no, and he said yes she will if I
tell her to, and he tells her to, I walked away
being so glad I had not given in to that
guy. I despised him. He had gotten me

so close to him, so yes it did sting. I thought George was mature and it was like tripping out of a frying pan into the fire. Now I am a mother. My decisions have to be first and foremost the well being of my child. My parents are the ones I am turning toward to guide me in how to be a parent. With that his family got him to leave the McDermitt Strip and go back to his house.

If you wonder about my faith in the Holy God and his word.

When I was ~~four~~ ^{four} years old we lived on Lookout Mountain in Alabama.

A lot of persons were giving testimony about World War II. The voice of my Lord

Another was Modular Builders in Lebanon, TN. I worked as their secretary and became suspicious. On their books they were losing a lot of money, but kept on ever so often infusing more money into the business. They were laundering drugs.

My dad told me not to speak about it so I wiped them out of my mind.

I know if you pursue this there has to be evidence I was in Jersey in the early summer 1967.

I was attending Tennessee Preparatory School because my mother was trying to marry me off and I wanted to graduate high school and attend college.

The fall of 1966 I worked with two agents with either TBI or FBI to capture two men who were operating a sex ring. I nor my father realized Raymond was behind that. He was messed up really bad on heroin and trying to sell me to my drug wish.

The agents were confused why they targeted me. He said I watched you walk back to the school and you don't fit the profile of the girls they target. You have the demeanor of a child beloved by their parents.

I told them don't worry about me I have worked with my dad since I was four years old I know how to handle myself. Their car is light blue and a brake squeaks when they put on their brakes.

The younger man ~~had~~ ^{with} brown hair looks to be 20's. The old man is gray headed. When I hear the squeaking brake I will start

running. You keep your eyes on them
two and don't let them get away. I
had seen the younger one pass a \$50 bill
to this waitress in the restaurant. He said
she's the spotter. I was then waitress but
they tipped her!

I heard the noise of them catching ~~them~~ ^{him}
and spun around. It was the young one
chasing me that time and he was fast
behind me. Raymond confided to me
he was the one who sent them after me,
he was selling me for drug money.

After I came back to Tennessee and married
Jerry Shaw Raymond kept sitting up
drug operations around me and when I
reported it, these two men took it,
and my dad joined in as doing the
undercover part and we kept busting up
his stuff.

He thought if I was around this I
would want it also, but I am a born
again Christian and have no desire for
anything that changes my behavior.

I don't know these two men's name
but I think they were the two who
went to New Jersey and busted up Chief M^s Duvet,
they probably protected mine and my Dad's identity
for his M. Morris

Some I remember is

The walking horse one. I wasn't with my dad, but we were connected by spirit of God. My dad delivered me and he heard the voice of God that day. Tell him how and how to take care of my mother.

To him I represented God is with me. With the walking horse one - he has wrapped himself with the horse bandage and is hiding because they have discovered it missing.

He said he prayed asking the Lord if these people kill me bring Phyllis to them over every rock until she finds my body and brings it home so the mother can come to my grave and talk to me about you kids.

I wasn't praying for my Dad's safety or thinking about that. A gully washer came and washed away the wooden bridge the bus used to come up the hill to pick up us. The bus had to cross the old steel bridge which shook and quivered under the weight of the school bus.

Coming home that day I had not prayed for my ~~dad~~ dad's safety or given any thought. We start across the steel bridge and it

shook terribly. Every one was scared, including me. I looked out the window and it was an angel shaking the bridge. He said your father needs you to pray for him.

Then I could ^{see} he was terribly afraid. He had the bandage wrapped around his chest shaking in fear because they were searching for the bandage. He was hiding in a stall, praying the Lord send me to help him out of trouble.

In the spirit I go with the angel and speak to my dad. Dad they have stopped looking come this way. In the spirit I led him to his car. Get in your car, let's go.

Everyone on the school bus was scared and Raymond tells them watch Phyllis if she isn't scared, don't be scared. So the bus went on across the bridge and took me home. That night my dad came rolling in and told me I prayed and you led me out of there. I said Dad it was an angel. He gave you to see his angel as me, because you trust me and didn't know his angel. But yes the essence of me was there and so was the Lord.

One time Raymond sat up for Jerry to take up with another woman and kick me to the curb.

That night knowing that's where Jerry was I was so tempted to throw his clothes out the front door. The Lord said if you want to stay married to him don't do it. Tell him how you feel.

I didn't and when Jerry came home I met him at the door. I said tonight I was so tempted to throw your clothes in the yard but I thought I married you for the short and long haul. The long haul is here. We have two kids to raise I need you to carry your share.

He later told me he had come home to get his clothes and leave but when I talked to him like that he thought how can I leave a woman like this? She is right we get along good together she's pleasant to live with.

The next day this woman Raymond had set up to split us up she waltz in my house and looking out toward the lake she says I like this. I'll love living here.

I said honey my husband is a lover of money, she said I know, I am also. I said honey when he looks at your car

all he sees is your crack. My ass is so lovely to him because he sees his assets in one piece. Your ass is so ugly because all he sees is your big greedy crack. She marched out my door in a huff.

Raymond came over and said I thought for certain she would work good for you. But Phyllis said some thing to her. She said your wife is the most jealous bitch she ever met and she wants nothing to do with you because of that jealous bitch of a wife you have.

Raymond said Little sis I didn't know you had it in you. I thought you were a Christian. I said brotha - you are right you don't know me. When you step on my toes I step back.


