(U// [REDACTED]) At the beginning of the interview, Agents thanked [REDACTED] for taking the time to follow up on topics from a prior phone call with Agents on 04/28/2020. [REDACTED] expressed concerns with talking to Agents because he did not want to possibly incriminate himself. [REDACTED] was concerned with former contacts acquired from past business ventures in the marijuana business. [REDACTED] was hesitant to further discuss STEVE BANNON with Agents. [REDACTED] believed BANNON to be friends with powerful people within the United States. [REDACTED] referenced BANNON's relationship with JEFFREY EPSTEIN. Agents explained that the interview was voluntary and he did not need to talk with Agents. [REDACTED] understood and continued to talk to the Agents.


