
**SA [REDACTED]** On 08/14/2019, an unknown female visitor introduced several types of contraband into the Metropolitan Correctional Center (MCC). A thorough search was conducted of the female visitor that yielded in the discovery of 3 bundles wrapped in black electrical tape. The 3 bundles contained smaller plastic bags that contained brown leafy substance, green leafy substance, pills, a cellular device, and rolling paper. The female visitor, identified as [REDACTED] stated that she was instructed to give it to inmate KEITH OUTLAW.

On 8/16/2019, a search warrant issued by SDNY was executed at the residence of [REDACTED] located at 2635 3rd Avenue Bronx, NY 10451 for a cellular telephone. SA [REDACTED] along with TFO [REDACTED] executed the warrant and seized an Apple iPhone 7. In addition, SA [REDACTED] along with TFO [REDACTED] executed the warrant and seized an Apple iPhone XR which was already in custody based upon a search [REDACTED] previously consented to on 8/14/2019.


