Dear Criminal Division, Whom it may concern,

I am contacting you in relation to the first two recent contacts regarding being a targeted victim of Epstein and Maxwell and a connected Criminal Network involved and connected to Epstein and Maxwell and is still operational in Australia and endangering my life, involving Australian Government sources, Australian law enforcement and police sources and a criminal network in the Australian Government system, and including connected and involved individuals of a criminal network.

I have attached a copy of the last contact made on the 2nd November 2022 and 3rd January 2023 for you review and in connection to my previous contacts with your department, seeking legal assistance and justice.

2nd November 2022

To whom it may concern,

I am contacting you concerning recent contact dated 3rd October 2022 and reporting that I am a direct target of Epstein and Maxwell that had remained undiscovered, and I reside in South Australia , Australia.

In the previous correspondence I supplied 2 USB flash drives containing Constructed Legal Case Files containing constructed documented evidence of being a target of a Criminal Network involving multiple connected individuals and prominent powerful people, which also included Government sources and Police sources.

I have now obtained documented evidence of the involvement of the Dark web/ Black market involvement in the targeting of an individual / myself by the Criminal Network involved.

I have submitted this evidence to Esafety in Australia and have requested an investigation into the report and requested their assistance.

I am contacting you to submit this final piece of evidence that was missing from the already submitted evidence, which is now conclusive to the final answer of how the Criminal network that has targeted me for over a 30 year period is operating.

I am submitting 1 USB Flashdrive with this report labelled Dark Web-Black Market and contains the files :

1. Identity Theft
2. Social media
3. Intellectual property Theft
4. Sexual Abuse Ring
5. Conspired Murder
6. Blocked assistance
7. Seeking assistance

The files listed above are the files I recently submitted to Esafety, Julie Inman Grant on 1st November 2022.

I am contacting you to provide more documented evidence I have discovered in my possession concerning an email dated 21st May 2009 of correspondence between myself and ADAM GURGLY Fake Identity of Epstein and Maxwell and name used by Epstein and Maxwell during the period of 2006-2013 Directly targeting the targeted victim, and contains details of the predatory behaviour by Epstein and Maxwell and what the interaction involved, and that they used the Fake Identity ADAM Gurgly as reported in previous contact and documented evidence involving the M.S.I.C design of the logo, and the documented evidence of the Australian Government sources involved and connected to Epstein and their involvement in the Sexual Abuse Ring.

I have also discovered the source of the commencement of the targeting which commenced at age 14 years of age while residing in Kadina and the motive behind the commencement, which involves an Australian Government source as the source, Attorney General of SA Vickie Chapman, and involves a connected Criminal Network involved in the continual 30 year targeting of an individual and involving multiple illegal criminal and immoral acts of criminality and against human rights and humanity.

I have attached and provided a USB containing 11 files and a report. The 11th file contains documented evidence of the motive and source of the targeting and the reason it began and continued for over a 30 year period involving Attorney General of SA Vickie Chapman.

The provided evidence in this file is the final explanation of how and why the targeting began and the motive as to why I in particular had become this target.

I am contacting you to submit documented evidence to support the reported documented evidence of the event that occurred in 2017 while residing in the area of Port Pirie, and involved alleged Conspired Police targeting involvement, which was confirmed in 2016 and 2020 by two sources confirming that I, the targeted victim was in fact a targeted victim of police targeting, which occurred in the periods of 2014-2016 involving the Port Pirie and Crystal Brook (SAPOL) Police Departments, which have been confirmed as being connected to Queensland Police Targeting and the individuals connected and involved in Criminal Network Targeting of an Individual. The reported event in 2017 involved Conspired Attempted Murder of the targeted victim due to her awareness by lethal injection to appear as suicide, which was unsuccessful, and then continued Conspired Attempted murder cases following this event occurring in 2018-2020 involving Australian Government sources involved and an individual connected and involved in Criminal network Targeting of an individual, which were also unsuccessful.

Involved in the 2017 Conspired attack of Conspired Attempted murder of the targeted victim due to her awareness by lethal injection to appear as suicide a Government Department, SACAT was involved in the Glenside Release from imprisonment / detainment of the mental Health Institution appeal, appeal submitted for my release by the targeted victim, myself in January 2017, hearing held involving SACAT 14th February 2017. The outcome of this hearing involving SACAT was a Conspired Falsified diagnosis of Schizophrenia and ordered lethal injections that had suicidal tendencies for a period of 16 months, and a Community Treatment order for 12 months following my release from Glenside, which followed 2 weeks following this denied appeal for my release. Prior to this hearing involving SACAT 2 doctors of Glenside, Dr Michael Lee and Dr Susan Cosoff, Psychiatrist were involved in Conspired Falsified diagnosis and illegally ordered medications, which commenced the process of the Conspired Attempted murder of the targeted victim due to her awareness by lethal medication / injection to appear as suicide, of which prior to this contact I did not have documented evidence to prove. I also prior to this contact could not prove that the Australian Government Department SACAT had in fact been involved in the Conspired Attack, but were only involved.

I am now contacting you to submit documented evidence to support the reported illegal Criminally Conspired attack of 2017 involving Australian Government sources, Australian Law Enforcement sources, and a Criminal Network involving involved individuals and the Government Department SACAT, and including Dr Michael Lee and Dr Susan Cosoff and Glenside Mental Health Institute, which concludes the reported criminal case and substantiates my report and submitted evidence, Constructed legal Case files, previously submitted, and the reported allegation of Multiple Conspired attempted murder reports, which has continuously been denied by Multiple Australian Government Departments and Law enforcement in Australia and the Australian Government System in the years of involving reporting 2016-2023.

I have in the year of 2023 contacted the Australian Government Department SACAT and requested access to the Freedom of Information Act involving and pertaining to their involvement in 2017 Glenside Release Appeal, documented as the following, and contained in the submitted files contained on the submitted USB / Individual files submitted with this contact and report:

- SACAT 2023—Email contact by the targeted victim requesting access to Freedom of Information Act pertaining to documentation of SACAT involvement in 2017 Conspired Attempted murder of the targeted victim by lethal injection to appear as suicide - Individual of SACAT stated and claimed that the Freedom of Information Act does not apply to SACAT - Individual stating this is contained in the submitted files contained on the submitted USB / Individual files

- 2023 Confirmation of individual of SACAT involved in 2017 Conspired Cover up and involvement in Criminal Network targeting of the targeted victim - 2023 individuals of SACAT NOT INVOLVED contacted the targeted victim following the first individual of SACAT denying the targeted victim access to the requested documentation involving the event of 2017 and supplied the requested documentation to the targeted victim pertaining to the events of SACAT's involvement and Glenside Mental Health Institution involvement in 2017 / Conspired Attempted murder of targeted victims awareness by lethal injection not appear as suicide and individuals involved

I am contacting you in reference to previous requests of investigations into this reported illegal criminal activity and am now requesting further investigations into this activity and the files submitted with this report, which now contains further confirmations of Government Departments involved, Government sources involved and individuals involved and connected in Criminal Network targeting of the targeted victim, and Criminal and Corrupt activity within the Australian Government System, the Australian Government and Australian Systems and Departments within Australia.

I have also attached a copy of my recent contact with the Australian Royal Commissioner and Commonwealth Ombudsman involving a report of the Criminal Network Targeting, Conspired Criminal activity and involved the submitted documented evidence files submitted to your department during all contacts, and including this report.

I have also attached a copy of my recent development ISPY.SUPPORT, which is a business development I am currently developing in the area of the Yorke Peninsula involving a support organization for Victims of Crime, Trauma, Abuse and Grief which is currently seeking interest in this area and a development of resolve unresolved issues of this nature, which as a victim of crime and the continuous denied assistance became a very real concern.

I am requesting this final part of the evidence be conclusive to the previous contacts and extensive documented files Character Reference, Stage`1, Stage 2, Stage 3, Stage 4 and the Esafety file submitted previously and am requesting your URGENT attention and assistance in this matter, as my life is so impacted by this criminal targeting I am still residing in my parents home in isolation from employment, business development and any form of social contact due to the persistence of the criminal targeting, which followed me from location to location in 2018 and is still currently active and not resolved, the report of Black Market involvement involving my

Identity being stolen confirmed in 2022 and confirms the targeting is still endangering my life and active.

I would appreciate your time, consideration and urgent attention and assistance regarding this matter.

I am contacting you in further reference to my previous contact dated : September 2022 involving Requesting investigations into Corruption and Criminal Network Targeting of an individual involving Government sources, Police Sources, Australian Government Departments and individuals involved and connected in Criminal Network targeting of a Specific individual.

The reported illegal criminal targeted activity consisted of :

- Money laundering - Conspired created falsified debts and stolen monies
- Identity Theft
- Computer hacking - Both systems
- Email hacking - all email addresses
- Social media account hacking - Blocked access and blocked marketing of business developments
- Conspired Police Targeting - Occurring at the Exact same time as each new business development and at the exact time of the targeted victims awareness of being a target of criminal activity and involving Conspired Police targeting / Sexual targeting / Conspired falsified charges and fines resulting in court appearances and falsified charges on the targeted victims police record and license record
- Multiple counts of Intellectual Property Theft which has now been recognized as Conspired Destruction of Carer for Sex demand of a Sex Abuse Ring connected and involving Convicted Child sexual predators Jeffery Epstein and Maxwell (convicted accessory to Jeffery Epstein) and occurring from the targeted victims age of 14 years of age until age 52 years of age, and involving multiple sources, including Government sources

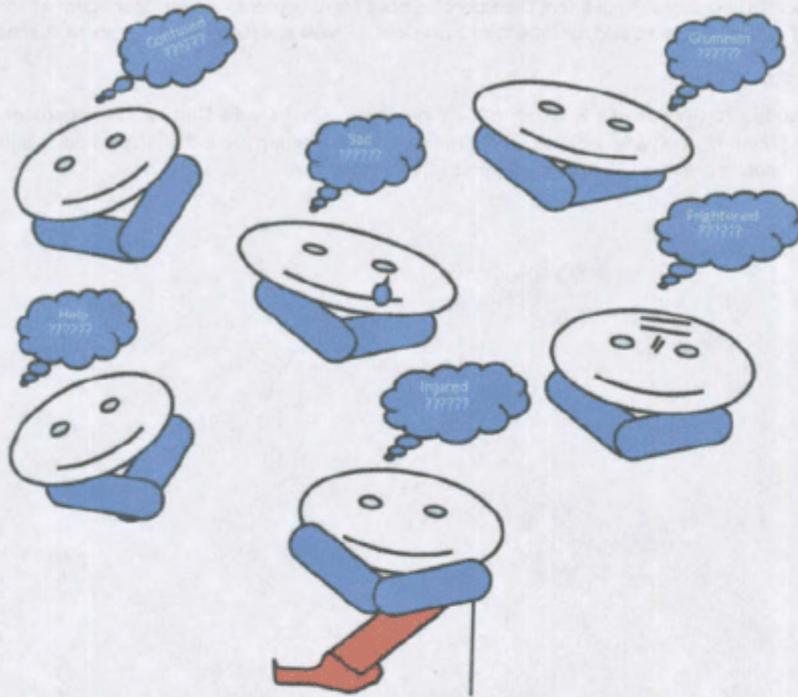

through the bank accounts created under the act of the stolen Identity of the targeted victim. The targeted victim was then informed that her Australian Tax File number was being illegally Misused in Australia and that her Bank accounts and Tax file number would be suspended.

[REDACTED] Service SA proceeded to question the targeted victim concerning her current Banking Institutions and balances of the accounts. The targeted victim provided the requested information to [REDACTED] and informed her of the Banking Institutions and the name of the Manager who had set up the bank accounts for her and could be confirmed by contacting the details of the Bank Manager provided.

Following providing the details of her Banking Institutions and bank accounts to [REDACTED] and stating that this reported activity was obviously a case of Identity Theft, [REDACTED] agreed that the contacted Targeted victim that this was a case of Identity Theft and that the case would be referred to Federal Agencies - Federal Police for a Legal Investigation.

[REDACTED] then informed the targeted victim that her bank accounts and Australian Tax file number would not be subjected to a suspension and that the targeted victim was not instigated in the illegal activity that had occurred as a result of the Identity Theft and would be subjected to a Legal Investigation by Federal Sources. The targeted victim was informed that she would receive confirmation via her email services. The targeted victim did not receive an email confirmation from [REDACTED] concerning this matter.

The targeted victim during this period was a victim of email hacking and computer hacking through email services and internet services involving Fraudulent and Malicious activity, blocked contact and altered security systems of the newly purchased computer system, which had been confirmed by a Computer Specialist company Pitstop Technologies, Kadina as email hack, and had also reported the Fraudulent and Malicious activity to the server GoDaddy, who was conducting an investigation into the reported Activity. The illegal activity of Fraudulent and Malicious activity on computer systems had been occurring for over 10 years and had affected both computer systems, a laptop computer and the newly purchased desk top computer, purchased in 2020, and was a victim of 96 hack attempts in 3 days of turning on the computer, which had been professionally setup by Pitstop Technologies, Kadina, which involved new accounts containing new business setup details, Multiple Security Systems containing 2 step verification systems and Password Protection Security Systems. The newly purchased computer system and professional setup was still subjected to hacking and email hacking as a result of the targeted sources remotely accessing the computer system and internet server, and had obtained the knowledge of the targeted victim purchasing the new computer by the use of the Illegal surveillance of the Privacy of her own home - Government and Police Targeting of an Individual - Government and Police Illegal Technology

Pitstop Technologies, Kadina continued to support the targeted victim by applying Multiple layered Security Systems to her newly purchased computer system and provided Digital Monitoring of the computer system for Security purposes and alerted her of the suspicious activity occurring in the newly created accounts and provided continual advice and information to protect her computer system.
The Fraudulent and Malicious activity was finally Confirmed following 7 years of reporting the illegal activity.

The use of Remote access to servers and computer systems as a result of Government and Police targeting of an individual and involving Organised Targeted Crime was confirmed by Telstra Head Office in 2021 following multiple reports of continuous Fraudulent and Malicious activity in all servers of Telecommunication Systems between 2015 - 2021, and had continued following relocation of the targeted victim to a new region of SA and following change of all details, including newly purchased mobile phones , multiple change of phone numbers, personal details to business account details, Multiple Security Systems applied and applied Restricted Access to the Telstra account of the targeted victim, but the illegal activity of Fraudulent and Malicious activity had continued despite the Security measures and precautions applied. The targeted victim was informed by Telstra Head Office that the only way to stop the targeted activity in her Telecommunication Systems was to drop of the grid all together.
The targeted victim refused to be bullied by the targeted organised crime and decided to stand her ground instead and would not be denied modern services because of the persistence of the targeted activity, and instead applied a watch dog reporting application on her mobile phone that reported suspicious activity and warned her of spam calls or contacts that would automatically report the phone number to authorities that had contacted her.

You have advised that you contacted Optus approx. 2-3 months ago to make a payment arrangement and spoke with a staff member you feel was not actually an Optus representative and this time you state the following issues:

- received blocked and altered text messages and there is evidence of phone calls that the consumer states she never made.
- noticed excess usage on her mobile, and saw her bills jump dramatically after this time. You have another mobile: (Optus) and that some photos from August were accidentally deleted.

Please note the mobile number you have provided is not an Optus number and is not listed on Optus systems.

To enable Optus to investigate this matter, it would be appreciated if you would provide a Statutory Declaration which sets out the details of your dispute. To assist you, we have enclosed a Statutory Declaration for you to complete and return.

It is important that the Statutory Declaration contains as much detail as possible, including:

- Your personal details; Name, DOB, residential address, occupation, employer and your daytime contact phone number/s
- Full explanation of what (including account reference / number) you are disputing and the reason you are disputing ownership of this account
- Confirmation as to whether you currently or previously have held an Optus service - and the relevant service or account details.
- Confirmation as to whether or not any other person is / was authorised to act on your behalf
- Any other relevant information that may assist Optus to investigate and resolve this dispute.

Thank you for your recent enquiry, and we are sorry to hear how this is affecting you.

eSafety and Adult Cyber Abuse

The eSafety Commissioner's (eSafety's) primary role in dealing with cyberbullying complaints is to assist with the rapid removal of cyberbullying material targeted at Australian children, on social media services.

Please be aware that eSafety, therefore, has no legislative power to investigate adult cyber abuse complaints, formally. However, we do work to guide people where we can and provide advice on what they can do themselves.

In the most serious cases, we will use our existing relationships and escalation pathways with social media services to effect take-down of harmful material that is considered to be serious cyber abuse in nature or, where required, we will refer the matter to law enforcement.

Digital surveillance

Your situation sounds like it may be digital surveillance, which is not an area we generally handle or have experience in. You may wish to approach your email (and any other relevant) service provider about the situation.

You may also wish engage an IT consultant to assist you in this matter or a cyber digital forensic expert to assist you further and we'd encourage you to consider doing this in the meantime.

Reporting to police

If you wish to pursue this or to make a formal report to police, the following steps may help you prepare:

- Prepare a timeline of what has taken place
- Place any screenshots you have in a word document (provide a summary below each image explaining what the screenshot relates to)
- Provide copies of any URL's you may have (you can obtain the URL by copying and pasting the URL address from your browser address bar)
- If you believe you know who the person is that is targeting you online, provide as much detail about the person.

I have attached our Adult Cyber Abuse Resource sheet which contains useful eSafety and support links. You may want to reach out to support services to help you in this difficult time.

We have now finalised your matter for now and hope the above information assists you.
