Hi. I just got off the phone updating Jennie on my call with Russ. Russ was very personal and friendly, and said he had thought about our "generous offer" to provide them a fresh proposed structure to consider, and documents, to advance things under the assumption that they will be comfortable with the tax returns and financial underwriting/risks associated with the same...but...he felt it would be best to pause at this point.
