Just bringing you up to speed on status.=If you recall I previously re-submitted package to penalty appeals coordin=tor and then contacted taxpayer advocate on lack of action by IRS appeals in Philly. IRS taxpayer advocate assigned case to

local appeals agent I have been working with. Bottom line result is that IRS appeals will be abating approximately 92% of the penalties we requested abatement back in 8/12. They will also re-calculate the interest once the penalties are removed for 04, 05 06 & 07. I will keep you posted on this as the final actions may take anywhere from 4-8 weeks to be posted into system. I estimate that the total reduction will be approx. 284k in penalty reduction/abatement and once the interest adjustment is made the total could well exceed 300k. I will let you know once we have account transcripts to reflect the adjustments. IRS will also be sending out letters once the adjustments are made.

Please let me know if you have any questions in the meantime. I am happy to report this news as this brings us very close to the conclusion of this phase. I will re-calculate time remaining on current IA's once these adjustments are ultimately made to your account.
