You must reschedule your registration no later than 3 full days before =our test date (not including the day of your test or the day of your reque=t), or your test fee will be forfeited.

Example:

The deadline to res=hedule a Saturday test date is Tuesday.

Payment must be received prior to rescheduling. The reschedule fee is US\$60=

Cancelation Policy

You must cancel your registration no lat=r than 3 full days before your test date (not including the day of your te=t or the day of your request), or your test fee will be forfeited.

Example: The deadline to cancel a Monday test date is Thursday.

Test=Fee Refunds

If you cancel your registration by the 3-day advance de=dline, you will receive a refund equivalent to half of the test fee you pa=d. The remainder of your payment will be retained to cover expenses for pr=cessing your registration and holding a seat for you at the test center. R=funds will be in the same currency and at the same exchange rate as the or=ginal payment. Cash refunds are not available. Refunds will not be given i= you do not follow proper registration procedures or fail to present accep=able identification documents at the test center.

Instructions for Test Day

Report on time to the designated test =enter with your identification document(s).

If you arrive after the rep=rting time, you may not be admitted into the test session.

Dress ap=ropriately to account for temperature variations at the center. Other than=your identification document(s), no personal items such as cell phones, pa=ers, handbags, or study materials will be allowed in the testing room, and=a secure storage area may not be available. Please plan accordingly.

Instructions Prior to Start of Test

Please be aware that all test takers will not begin the Speaking section of the test at the same time. Other test takers may be speaking while you are working on another section of the test. If you think you will be distracted, we suggest you wear your headphones during the entire test session.

Follow the instructions on the screen. Be sure that your microphone is properly positioned and adjusted to allow for the best possible recording. Speak directly into the microphone at your normal speaking volume.

Raters have been trained to ignore irrelevant noise when scoring speech responses. They focus on the speaker's words and screen out background noise.
