There are non stop flights from Paris to St Maarten. Then you would have to book a separate flight on LIAT which has 1 flight a day into St Thomas at 1.20pm. The problem is that the non stop flights get into St Maarten from Paris in the afternoon which would make it too late to take the flight to St Thomas on the same day
