The name of the agency is New Tours. The best tour i was recommended is 12 days "Atlantic Stars" which includes following cities:

- 1st day - arrival NY.
- 2nd day - tour of NY (6-7 hours)
- 3rd day - travel NY - Boston
- 4th day - travel Boston - NY
- 5th day - travel NY - Niagara Falls
- 6th day - travel Niagara Falls - NY
- 7th day - travel NY - Washington DC
- 8th day - travel Washington DC - NY
- Days number 9, 10, 11 - Free days in NY
- 12th day - flight back to Russia from NY

The cost of the tour is \$1680 for placement in a hotel with double occupancy. If we prefer single occupancy there is additional charge of \$780 (\$65 per night). Total cost is \$2460.

We can also buy additional tour NY only for 5 days, that will extend her visit in NY. Cost of the tour with single occupancy in the hotel is \$1095. All guests are required to be on the tour, otherwise agent will notify the consulate. We have to pay deposit of \$500 to New Tours that will include \$ 50 for the support letter for the interview for VISA. If the VISA is rejected the deposit is refundable with the deduction of \$50 for the letter. I would like to remind you that we can pay for the tour only when we have a date for the interview in Moscow consulate as I have to know approximate time for visit. The travel agency accepts payment in cash, checks and credit cards. For Credit card payment there is additional 3% charge.
