By the way I read in a news paper of an interesting accident which took place in Tel Aviv. Between two of our cousins in blood, two people carrying the French nationality but originally are descendants from North Africa. Claude Isaac Khayat and Eric Roubi accidentally crashed and killed Miss Lee Zaitouni 25 years old, who died in hospital shortly after the accident. The two then travelled immediately to France.
