Rich,

The Board call went very well and I wanted to report back to you.

We have unanimous consent to move forward with a financing of \$1.0-1.5 million for 51%-60%.

I have a follow up call scheduled with Jimmy Gould for Monday morning at 10am to discuss the deal, name Jeffrey as the investor, review terms in general -- assuming that timing works for you and Jeffrey -- and make the connection between you and Jimmy to take things forward.

Jimmy and Jeffrey have spoken in the past so I believe there is an existing level of mutual respect. David Peterson has also volunteered to help with closing. Jimmy was enthusiastic about the improving revenue picture (and even volunteered to make a connection to the family that owns Amway to help us with 2011 contracts), and sounded very level-headed about dilutive terms and ready to swallow hard and make this happen.

So a very positive morning I think.
