We would like to let you know t=at we want to raise this issue to the management.

As Crissia still remembers the harassment of Jon Johannesen and Debbie Donaghey (former Chief Engineer / 2nd stewardess) that left her an emotional trauma, We can see Marie's characteristics similar to Debbie when they were influenced by alcohol.
