I've attached Simon's previous 'top up' order for you, as well as a larger one he placed at the beginning of the charter. We have changed meat suppliers and now use a butcher in New York who can supply us with much better quality meat.

Concerning your email on Sunday looking for availability of items, I would have no problem supplying the majority of the items. I have never seen Tajin, Valentina or Pepsi Max on island. As far as I am aware chicharones are pork rinds or pork belly, both of which I would be able to get. Lastly I am assuming that you mean canned grapefruit segments. I haven't seen them but I believe I should be able to find them.

For the specialty breads we would need at least 2 days' notice.
