Thank you for confirming that Mrs Hana has received her ring & earrings

MY Te Manu has now returned to Europe having recently completed the 3,246 nm journey from St. Maarten to Gibraltar in just under 10 days - Weather was far from ideal on the crossing & MY Te Manu has been sheltering in Gibraltar for the past two days awaiting conditions to improve before continuing east

On board MY Te Manu, Mr. Hanna's chair was placed in the (Bridge deck) Main Salon which is the main gathering area for our guests & the location of the largest flat screen TV

Security is a concern for Mr Hanna & we arrange for a 24 hour security watch to be maintained at all times (even whilst berthed at secure marina's) by crew during the charter.

Mr Anna often moves to his reclining chair during the early hours of the morning so we always ensured that the interior lights & TV were left on at night

Mr Hanna was comforted to see a member of the crew on over night security watch & would often spend time chatting with the watch keeper.

Mr. Anna rarely used the elevator as he enjoyed the challenge / exercise of walking the stairs and would only use the elevator if he was feeling unstable or disoriented.

Unfortunately, Myla is on Medical leave at the moment but I will try to reach her if you have any specific questions
