Our firm is public relations counsel to Jeffrey Epstein. I am writing about the Sunday, March 13, 2011 article, "How Prince Andrew shared a room at Epstein's Caribbean hideaway with a busty blonde who claimed she was a brain surgeon."

The last two paragraphs of that article state: "[REDACTED] an ex-FBI task-force supervisor who has led the campaign for the Epstein case to be reopened, said: '[REDACTED] went up against the entire town of Palm Beach to do what was right but he is not [REDACTED] any more because of this. And eventually Epstein was given an immunity from prosecution deal the like of which I have never seen in my entire career. "

[REDACTED] was never an FBI Supervisor. He was a [REDACTED] [REDACTED] He currently is and has been for some time a private investigator for attorneys, Scott Rothstein, who is serving a 50 year prison sentence and his partner Brad Edwards. Both Messrs. Rothstein and Edwards represent women who have filed civil lawsuits against Mr. Epstein. There is quite a difference between an FBI Supervisor and a local police officer, especially one who was fired from his job. And, of course, as an investigator for a plaintiffs lawyer he is hardly the objective source he holds himself out to be..
