It was good to talk to you earlier this week and as I said I completely understand your concerns and frustrations as does the Duchess. We discussed a number of ways of trying to rectify this situation including:

- Public comment by the Duchess in forthcoming US TV interviews
- A statement from her
- A letter from her

In reviewing these options there is a concern that any comment "live" and "on air" might generate more negative than positive for you, in terms of follow on questions, therefore a letter of clarification – as suggested by you – would be more appropriate. To this end could you be kind and let me know the exact wording that you would like to see in a letter and I can then put this to the Duchess and hopefully we can resolve the matter soonest.


