*Confirming our conversation of Thursday 10th May*

*The trial 2 weeks in NYC for Jamusz and [REDACTED] did not go well, you do not wish to employ [REDACTED] and Jamusz. is to be released. I will travel to PBI and inform Jamusz of this, with the hopes that he will stay on for a further 3 to 4 weeks to complete a handover also giving time to employ a handyman.
