- 2) it would be so nice if we could meet tomorrow in the conference room at yacht haven unless you feel strongly that it needs to be out east. I have to take off as soon as possible after the meeting. Your call.

- 3) At AYH I suggest you get 1.5% management fee, zero mark-up on any and all fuel (so it's at cost)y, most favored nations pricing on any and all slips you use (up to a max of 5) and on your leases. This assumes you stick with the same slip count and same relative office space requirements.
  - 4) On resale or refinancing of the asset you receive 75% of the first \$1mm equity distribution and it returns to 50/50 thereafter.
- (3) And (4) constitute what I believe the best we can do w/o creating problems but still respecting your sentiment. I believe that it makes a real effort towards making this right and gives you an immediate \$750k edge on the first new major distribution.
