I am going to take you up on your offer to help. I have spoken to some people regarding obtaining approximately a 50K small business loan and my issue is going to be the fact that my foreclosure is not 2 years out.

Hope all well. Just wanted to give you a heads up. I am contemplating and in the process of forming my own LLC and performing freelance paralegal and private investigator work. I have met with a few people and I think from a mental health and business standpoint, this may be the best decision for me and my future.
