Todd – some follow up points to our conversation today about the arrest of Fabian Thylman of Manwin (Playboy) and its implications for our guys:

- Fundamentally we are in a different business from Manwin. We are a pipe (social networking, cams); he is an adult content owner and distributor through his Tube businesses
- We are a US company, audited, registrant with the SEC, our CEO and CFO sign SARBOX reports, we comply with all applicable law and regulation (e.g. "2257" record keeping as well as best practices (we never sell subscriber emails or other identifiers, we scrub every profile that we put up to make sure it's real, we have automated software that constantly scan the sites for illegal/objectionable material))
- We pay our taxes (although the prior owner of the business didn't pay VAT in Europe prior to us buying the business; our public filings show how much time and money we have spent cleaning that up)
- There has never been any suggestion that we engage in, promote, or willfully ignore evidence of illegal activities on our websites – very different from backpage.com
- We keep a low profile – unlike Fabian, who took a very high profile stance on "barebacking" (use of condoms by actors) in the industry
