[REDACTED] called Una this morning and requested that David be paid via payroll per terms of 13 weeks at 1,000 per week
Based on how information was presented to us and no mention of Island Grounds payroll my understanding was that this was contract work
If you decide to put David on payroll it will cost you an additional 9% or 1,170 to cover cost of payroll taxes, workers comp and unemployment insurance
In addition we may want to ask for an indemnity agreement from David that he has workers comp so we protect from erroneous lawsuits
Please advise payroll or contractor and whether or not to pursue indemnity agreement
