I see that you included the air conditioner in the quote but I did not see a generator. We would need to add this if not included.

I am assuming most of your boats are wired for 50 hz, would it be possible for you to outfit ours with 60 hz equipment?

We would also like to add radar to the electronics package on the boat.

We are pricing out engines and wanted to see what shaft lengths you are using?

Do you have any performance data on the boat with the Yamaha outboards?

The pictures look great. I think the layout of the cabin would work very well for us. Please find the answers to your questions below.

1. Engines - 2 x Yamaha 350 hp? *That would be great.*

2. St. steel rollbar in the aft - is it needed? *We don't need a rollbar but I would like a bar behind the engines to protect the cowlings. *
3. Inside the cabin:
 - a. A/C?* Not essential but would be nice*
 - b. Benches or single seats? *The two front seats we would like as individuals. The others can be benches*
 - c. Bow compartment - how adjusted: sleeping part, luggage, other?* Set up for luggage. Shelves with tie down straps would be perfect.*
4. Navigation equipment?* I'm a big fan of the newer Garmin models. Two screens with radar, chartplotter and sounder.*

The Virgin Islands is a very interesting destination!

Enclosed please find some pictures of boats which we manufactured in the past.

As you can see we can adjust it to different requirements.

The boat is able to carry 12 (2+10) persons in the cabin and 6 outside on the "U" bench.

The luggage may be kept either inside the seats or in the bow compartment, where we can place special shelves.

Inside the cabin we mount cabin heating (I guess it is not needed for you) and A/C.

Propulsion can be both outboard (up to 4 engines) or single/twin inboard.

I suppose you would need 2 x Yamaha 350 hp.

The color of the boat is up to you.
