When I came to the island I saw one major problem. Landscaping was running from area to area and putting out fires, as directed by Ana. It was one problem area after the other.

So, I decided to split up the island so Ana took care of the homes, and I would get

landscaping in shape. Irrigation is lacking, and as you can see when you look at the basket, and areas surrounding it... It looks much better now that irrigation is working.

I wanted to get all open projects done and get the crew into maintenance mode. As you can see, the engineering area is no longer a junk yard, next week the tunnel will be organized with racks and all workshops clean and neat.

Infrastructure is paramount in my experience. When all is clean and neat, it is easier to maintain it that way.

It takes a little time to learn the ins and outs of a new place. What I'm learning here is that it's not enough to tell people what to do.

I will be done with landscaping next week and will at the same time get more involved with the remaining areas of LSJ
