

Regarding the travel plans, we are applying for entrance visa to USA, this might take approx. 20 working days.

Maybe I will come myself - I need to renew my Canadian passport.

In the meantime, we are still investigating the open issues, and have contacted an experienced sound surveyor from a technical university and independent sound research center.

Please supply us with some sound recording made by a professional/semi-professional microphone or at least a PC with e.g. Windows Recorder:

1. In four different places:
 - a. in the bow compartment of the cabin
 - b. in the middle of cabin
 - c. outside the cabin
 - d. in the middle of cabin after making a simple foam sheet curtain (fixed with tape) of the entrance to the bow

2. Please send a video of boat while cruising (better to record from another boat which is cruising next to the Sportis)

3. Engines can be in standard regulated up/down on bolts. Please inform what is the still possible regulation (how many bolts up/down can be adjusted) in this particular case

We have undertaken several consultations which will give some suggestion in the coming few days.

Regarding the visit, as I mentioned due to family matters I cannot come personally.

I discussed this matter with my father, the chairman of the company, and he is planning to visit you.

Maybe with one more person.

We checked the route, the fastest takes 30 hours one way...

Gdansk - Amsterdam - NY (or Atlanta) - St Thomas

Additionally the visitors will probably need a entrance visa to USA - this takes a few weeks.

I ensure you that we are willing to solve this matter asap.

If possible, please send a video of the boat making noise when standing (not cruising).
