The client does not wish to own the aircraft, he is funding us to operate his flights for 15 months.


With the alternative I mentioned, Aerco are the purchaser and will remain the registered owner unless we can make N908JE happen

Obviously in the case of Mr Epstein's aircraft, if we can make it work, he remains the owner, as I said, until the last payment is made, then the owner will be Aerco Logistics. The operator and owner will be Aerco Logistics Limited.

The client is NOT part of AERCO but a long standing repeat customer who trusts us to deliver. He has no interest in owning the aircraft or getting involved in it's operation beyond saying when he wants to travel.
